Assistant Director Gobble reported on the recent HVAC work that is being conducted at DSS. We have run into unexpected obstacles that require special attention. The most recent phase of the project (Child Support Area) – the HVAC team has found two old decommissioned steam pipes to have asbestos pipe wraps. According to the HVAC team, these wraps are common practice in older buildings. The pipe wraps are safe and present no hazards as long as they are undisturbed. The HVAC team will remove these older lines to assure they pose no risk and continue with the new HVAC installation.

The County has scheduled certified abatement contractor for July 5, 2022 to begin the work. They anticipate the work will last for three days. The Child Support staff have all been relocated due to

HVAC process so no new moves were needed. The area will be tightly sealed with no access to employees during the remediation work. Once the work is completed, a separate outside firm will complete air samplings to assure the area is completely clean and in compliance with air quality standards. Once both of these processes are complete, the HVAC team will return to the space and continue with the installation process.
